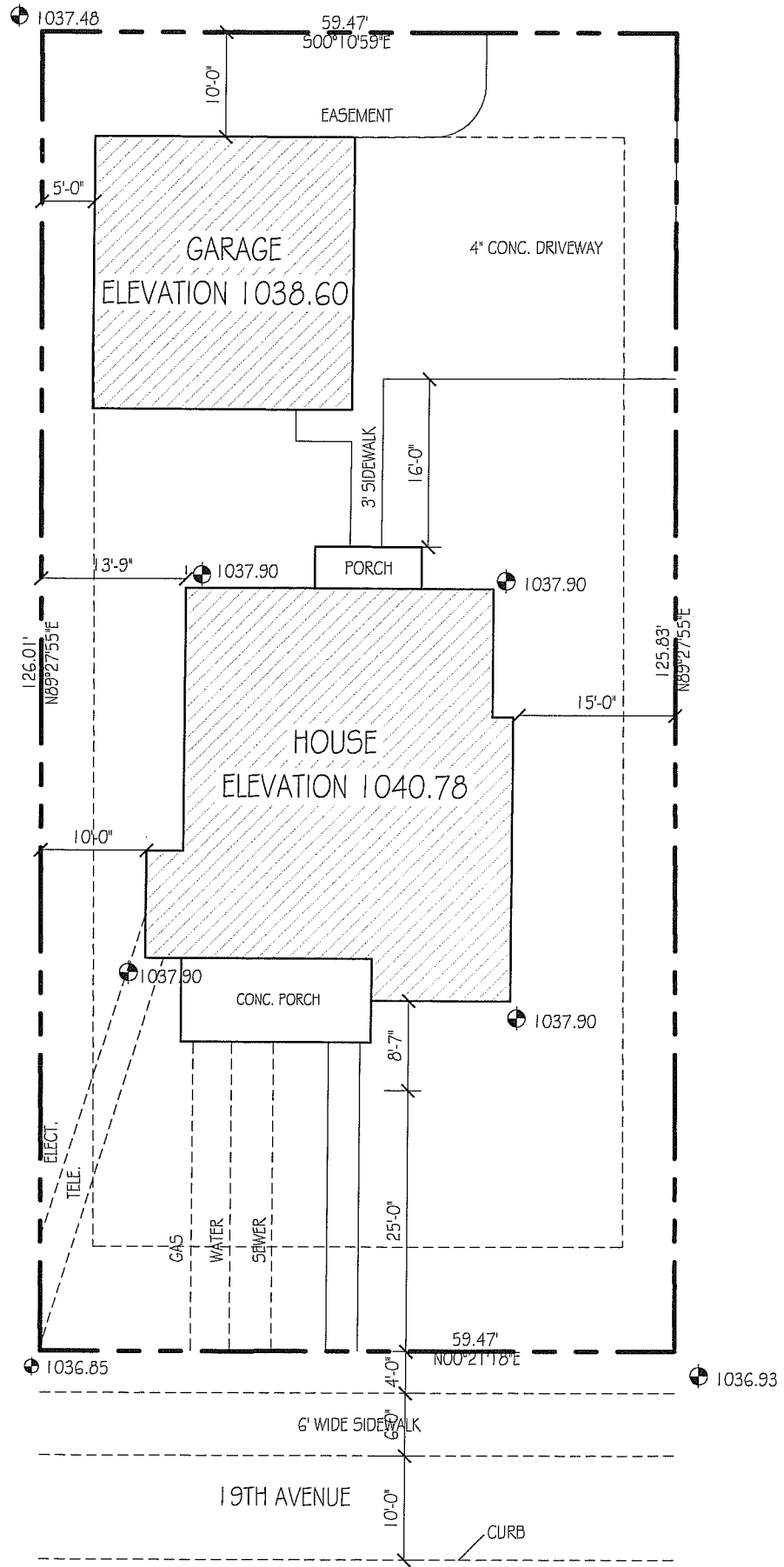
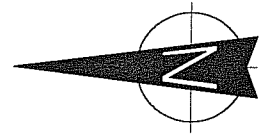

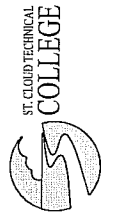


SP-1 SITE PLAN

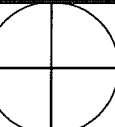

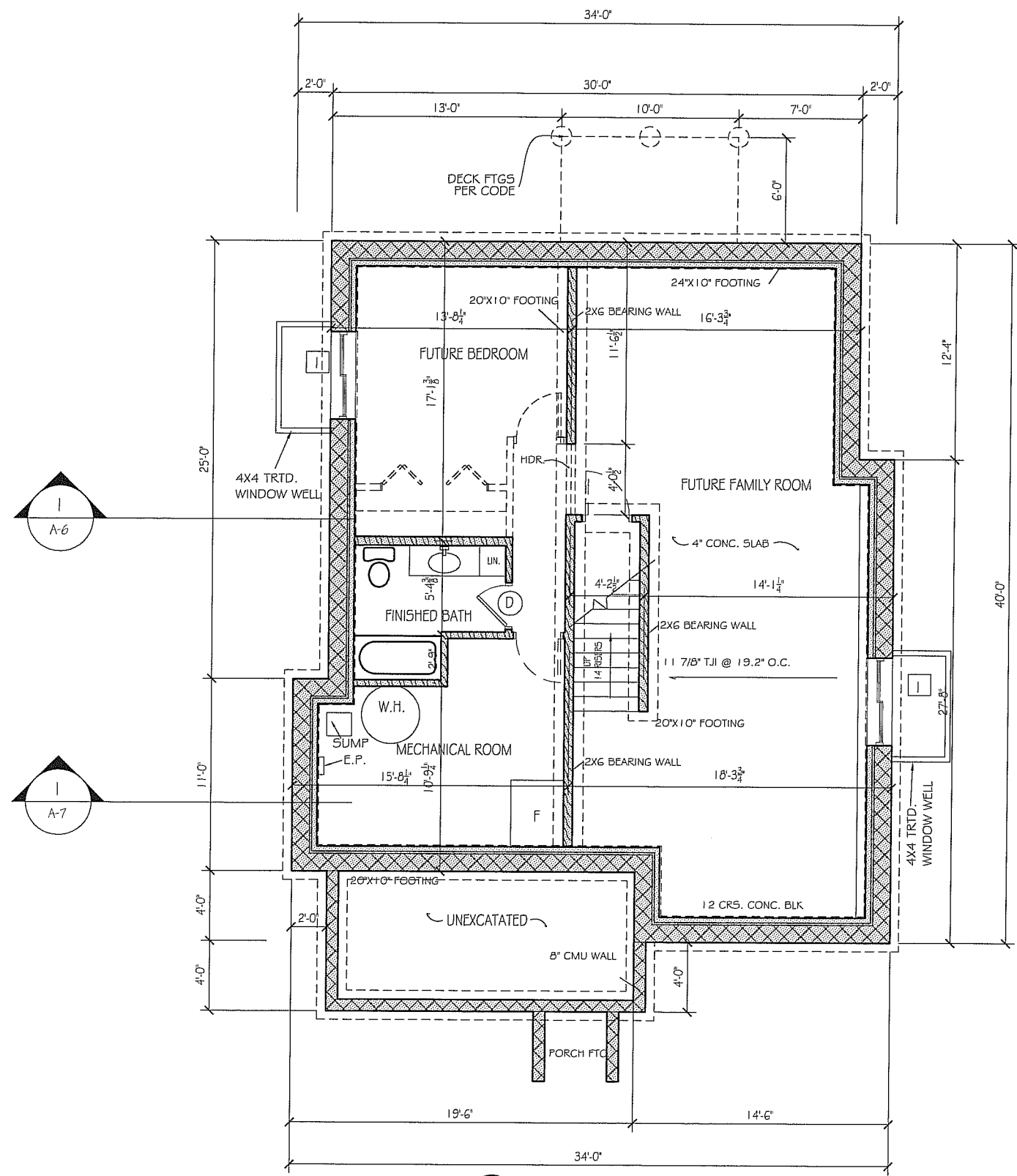

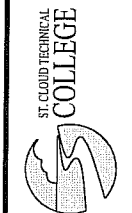


A-2 FOUNDATION PLAN

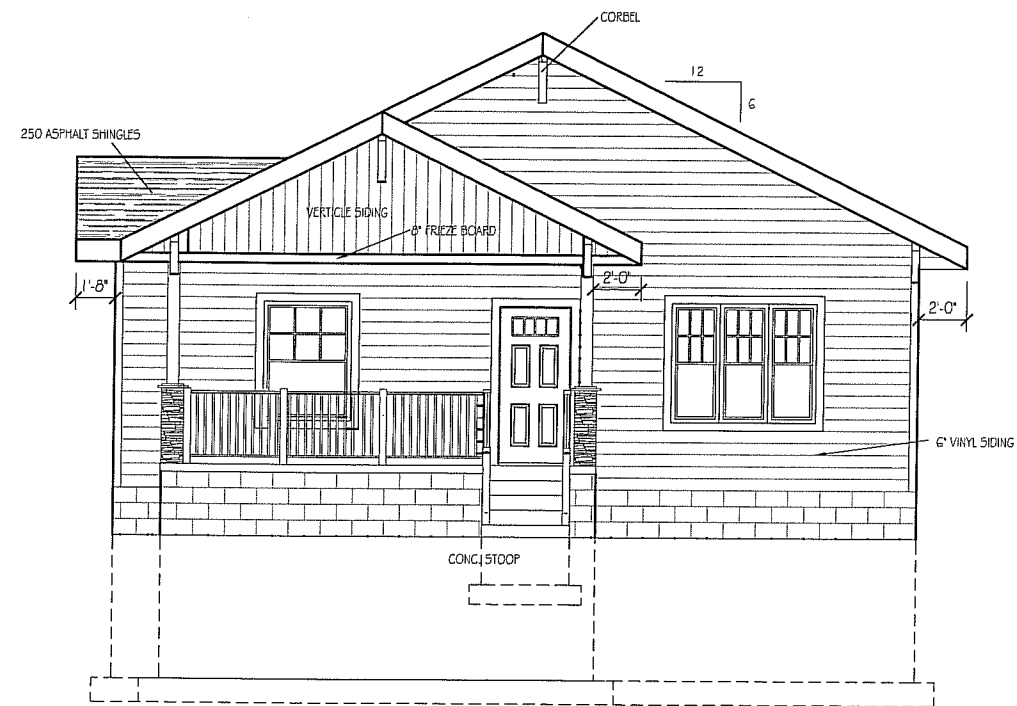
1 SOUTH ELEVATION

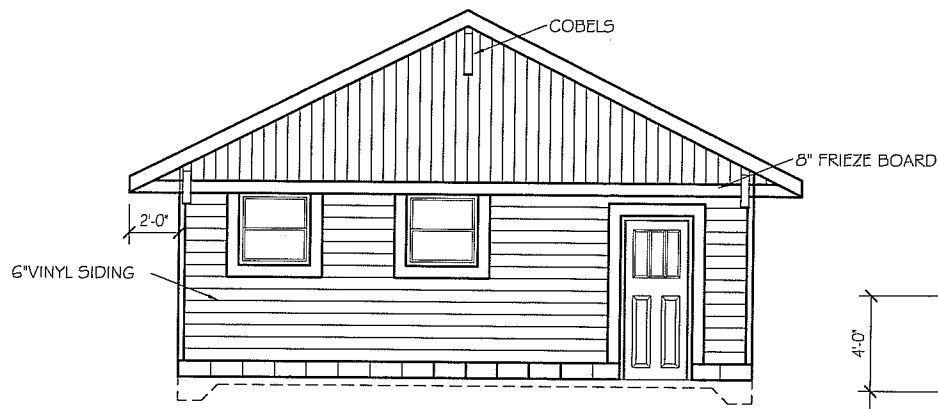

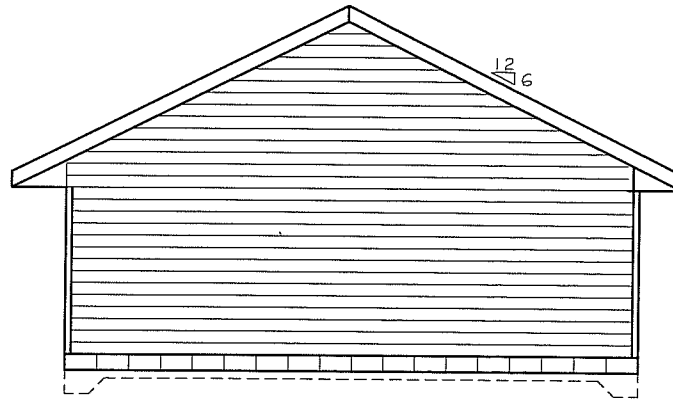


3 NORTH ELEVATION

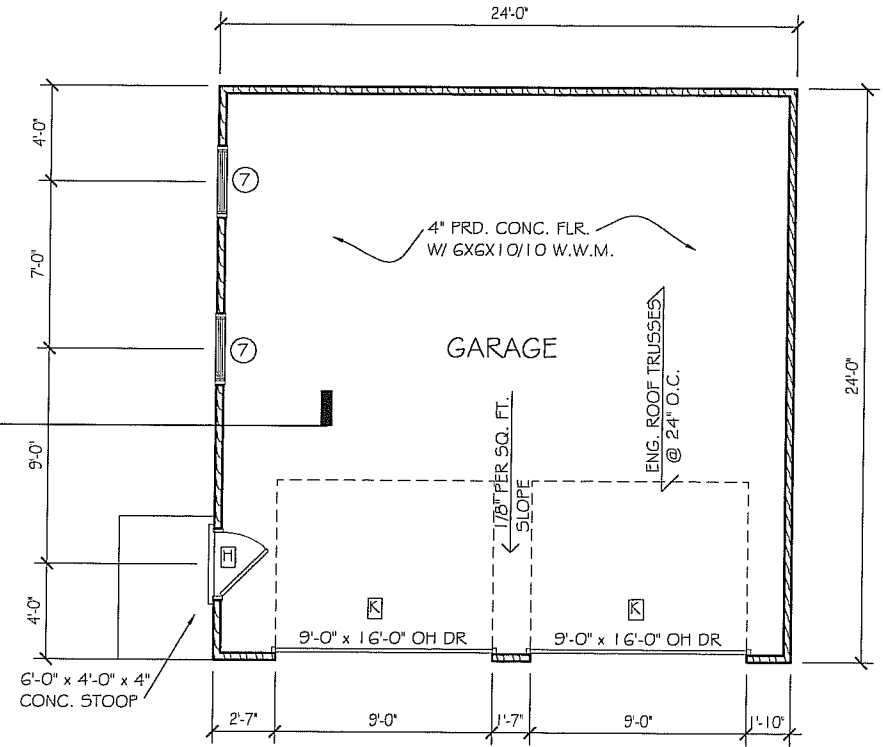

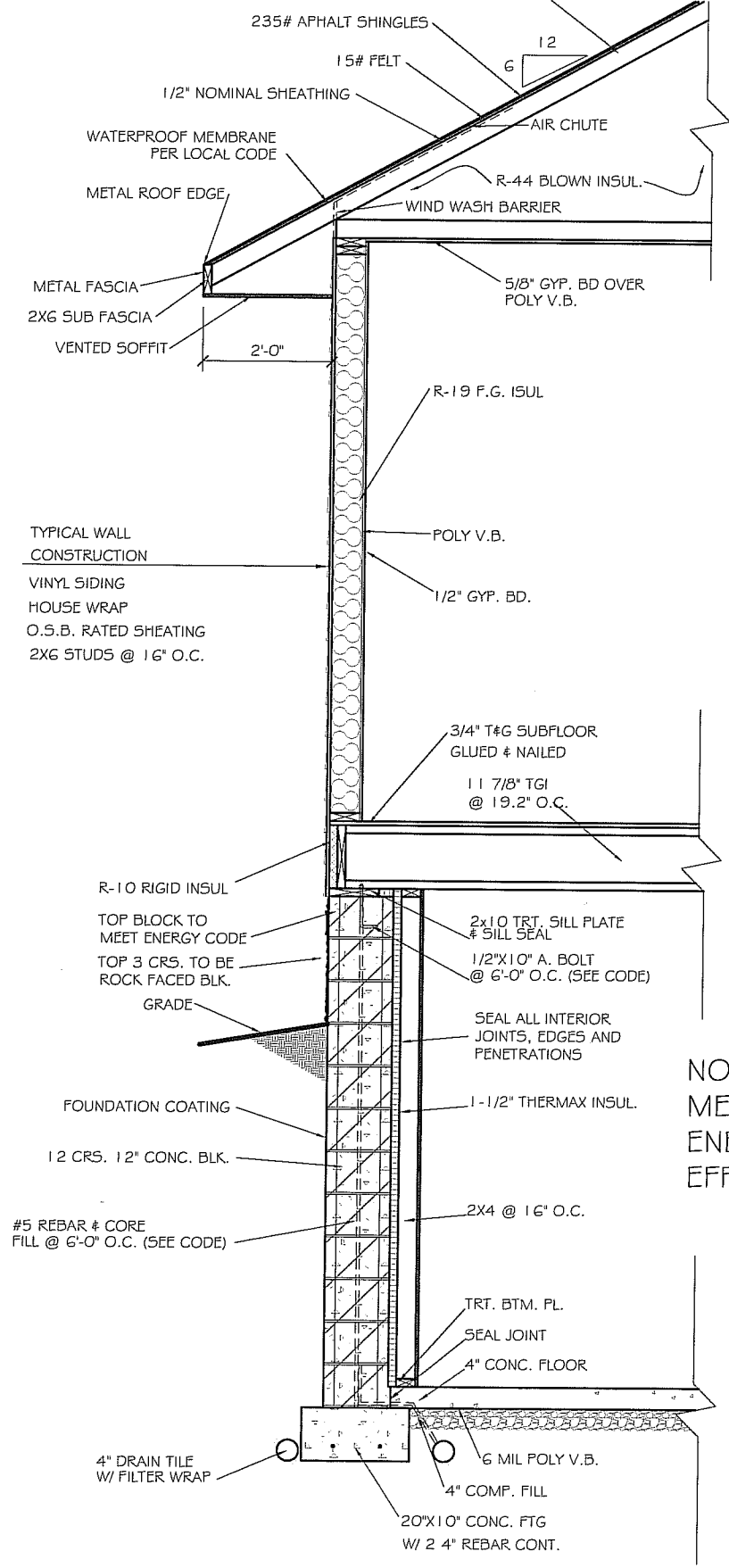

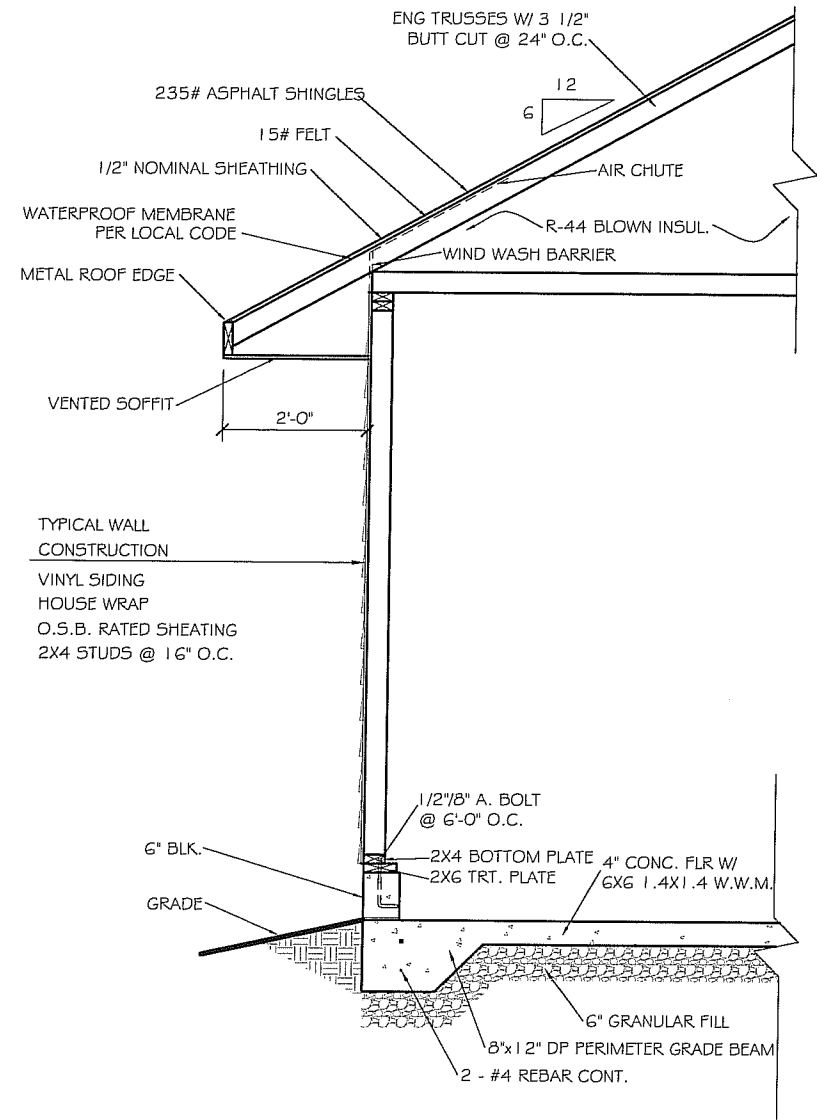
